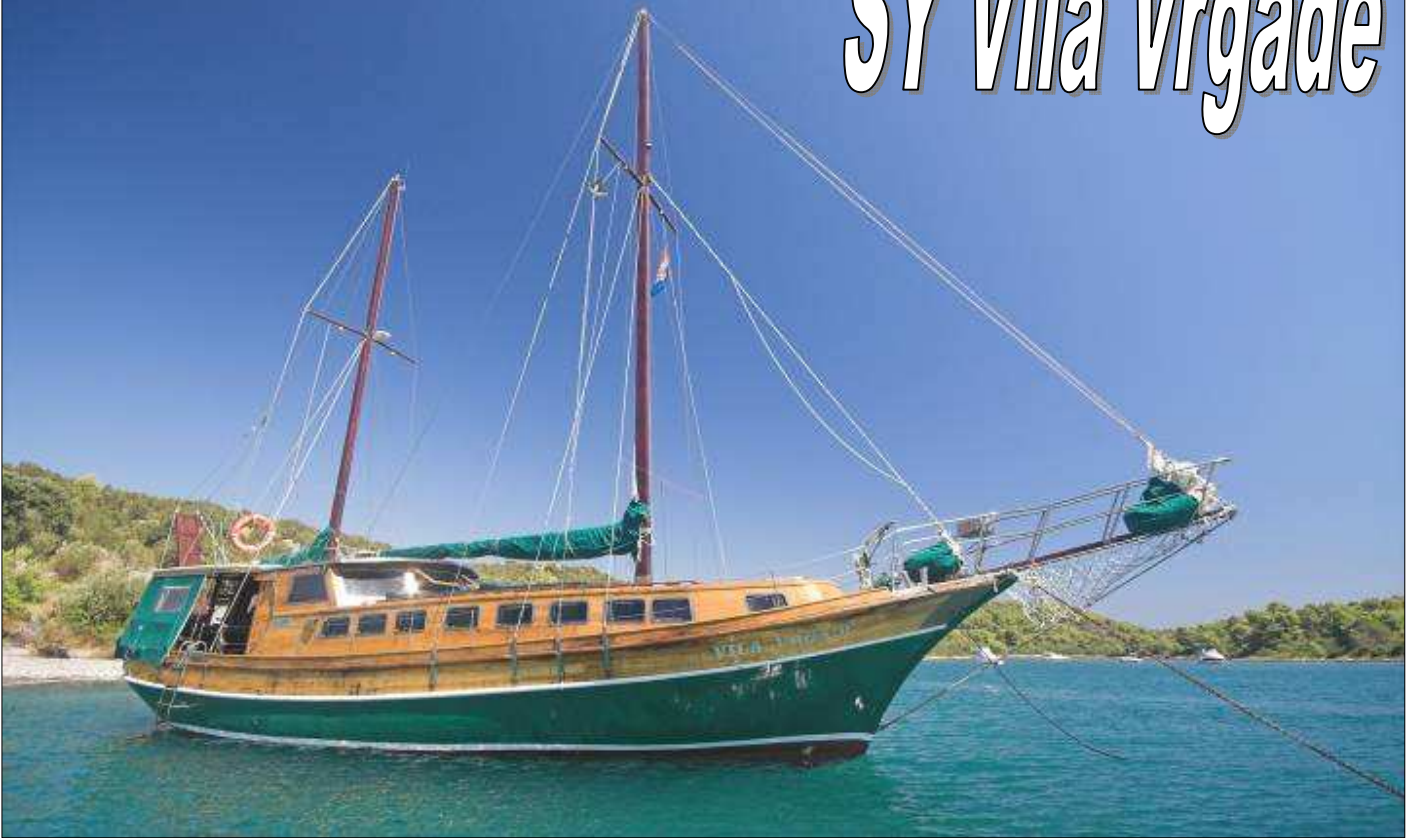


SY Vila Vrgade



Gulet name "Vila Vrgade" (fairy of Vrgada) was taken from a legend told throughout the generations on our island of Vrgada. In this legend there was a good fairy that lived under a cliff, in the hill above the village, looking out onto the Kornati islands. It was said that she watched over the villagers and protected them from pirates and bad weather.

Vila Vrgade gulet is meant for high tourism and has been given five stars for its accommodations and professional crew who will guide you on your trip. A long time after your holiday at sea you will still be talking about delicious meals, clear water, small villages and natural bays. M/Y Vila Vrgade is a classic two masted caique - of approximately 18 m length - with spacious interiors and a comfortable and large cockpit. 1) CHARTER COST

CHARTER FEE: All rates are in EUR/week

Includes: Shipboard accommodation, permits, insurance, all equipment on board, tender with outboard engine, linens and towels, fuel for main engine, 4 h of navigation per day, crew salaries

2) OBLIGATORY: 1000 €/week,

Includes: yacht cleaning, town port taxes and fees (but not marina fees), sojourn taxes, gasoline for tender, diesel for generator running 24/h day, internet connection daily

3) FOOD:

Half board: **250 € pax/week**(breakfast + lunch)
 Full board: **350 € pax/week**(breakfast + lunch + dinner)

4) BEVERAGE OPTIONS:

- A) Beverages on yacht bar only – by bar price list, in this option clients are not allowed to bring their own beverages on board
- B) All inclusive domestic package - includes Croatian wines, beers, spirits, soft drinks, natural and mineral water, coffee, tea, juices – 150 € pax/week
 All inclusive domestic non alcoholic package – 80 € pax /week
- C) Beverages completely supplied by clients – cost of service of beverages: 600 €/week

5) EXTRA COSTS:

- DUBROVNIK VISIT FEE on Split – Split route: 1.000 €
- EXTRA NAVIGATION: 50 €/h
 (This cost is already included in Delivery Fee and Dubrovnik Visit Fee)
- MARINA FEES: when client explicitly requests, yacht will be moored in Marina instead in town port. Client will pay costs of Marina fees.
- DELIVERY FEE for embarkation / disembarkation in any other port except base port. Please check this cost for each port.

Above mentioned prices DO NOT INCLUDE:

Transfers to or from the yacht/hotel/airport, shore excursions, national park tickets, adverse activities (scuba diving, big game fishing, rafting...)

Guided tours, gratuities/tips for the crew.

Marina fees: in Croatia there are two kinds of ports: Town ports and Marinas; Marinas costs are not included in Obligatory, Town ports costs are included

Booking terms:

Option is placed on explicit e-mail request, and is active until agreed date. Booking needs to be confirmed while option is active. Option expires after agreed date without special warning. Please take care of your option expiration.

Booking is confirmed when agreement is signed by both parties and deposit paid.

Payment conditions:

Deposit: 50 % of charter fee – immediately, as confirmation of booking

Balance: 50 % of charter fee + Obligatory + Other costs - not later than 6 weeks before charter commencement

Mean of payment: wire transfer to account of Central Booking Agent
